I : 20th GENERAL BODY MEETING OF AISBRF :

We are pleased to inform that the CEC Meeting of our Federation was held on 22/08/2019, and one of the important decisions taken was holding the 20th General Body Meeting of the Federation. It was decided to hold the Gen. Body Meeting at Vijayawada and the event will be on 18/12/2019. The preparation has begun in right earnest. The E.C .Meeting of A.P. State Committee was held on 21/09/2019, followed by a meeting of general members. The Central Office of the Federation was represented by President, General Secretary and the Dy. Gen Secretary. Wide ranging discussions were held to ensure success of the Meeting.

The following decisions were taken in the CEC Meeting:

1. The delegate attending the AGM will have to pay the delegate fee of Rs.300/-. Those, who come from outstation will be provided free accommodation for 24 hours, morning breakfast, lunch and dinner. Those who intend to stay beyond 24 hours, may do so at their own cost. If they want to stay in the same lodge, they may take the help of the reception committee.
2. A souvenir will be brought out, in commemoration of the event. All the state units and affiliates will co-operate in collecting advertisements and the matter for advertisement will positively reach us at least a month in advance.
3. Donation coupons may be issued to our well-wishers, to raise funds.
4. The office-bearers/activists may be requested to donate liberally, to meet the cost of the event.

We are happy that the CEC members present in the meeting, volunteered to donate for the Gen. Body Meeting, ranging from Rs.1000/- to Rs.10000/-. **We appeal to all our activists and well-wishers to be generous enough to donate their might to meet the cost of the event and also attend the General Body Meeting.**

II. IBA MEDICAL INSURANCE SCHEME:

You are aware that the Medical Ins. Scheme of IBA needs to be renewed w.e.f. 01.11.2019 and the management has already issued Cir.No.505/2019/BC dt.01/10/2019.

The Salient Features Of the Scheme are:

1. Only existing retirees who are covered under the IBA Group Medical Insurance Policy for Retirees' and employees who have retired during the Serving Employees' policy period 2018-19 will be allowed do join the IBA Group Medical Insurance Policy for 2019-20. Retirees who have not joined the scheme earlier will not be allowed to join the scheme now.
2. There is an increase in premium for renewal of IBA Group Medical Insurance Scheme for the year 2019-20 for without domiciliary cover policy and Super Top up Policy.
3. There is an option to all the optees to get covered under Super Top up policy without domiciliary cover if not opted earlier, by paying additional Top-Up premium.
4. Eligible optees shall submit their request for renewal in Annexure-1 to the respective pension paying branch or the nearest branch, if it is convenient, positively before 15/10/2019 and maintain required balance in their accounts or else it will be treated that they are not interested for renewal.
5. Co-operation of all the eligible retirees/optees is solicited in the matter for the smooth completion of the renewal process.
6. Once the premium is remitted with specific option, no option change will be allowed.
7. Existing retirees who are covered under With domiciliary (OPD) policy may switch over to Without Domiciliary cover but option to switch over to With Domiciliary (OPD) policy is not allowed.

III. SUBMISSION OF LIFE CERTIFICATE (Cir.No.500/2019/BC dt.30/09/2019.)

You are aware that it is mandatory for all pensioners to submit life certificate in Nov. every year.
